Course Overview

This section gives you an introduction to what you will be learning in this course, plus course outcomes, career opportunities, and student support.

Introduction

The Diploma of Nursing provides the skills and knowledge to work as a safe and competent Enrolled Nurse providing quality nursing care in a variety of healthcare settings. Successful completion of this course allows students to apply for registration with the Australian Health Practitioners Regulation Agency (AHPRA).

Philosophy:

This course recognises that the holistic care of a person is based on the uniqueness of individuals physiological, [psychological](#), social/cultural, spiritual and developmental health care needs throughout the life span. The impact of chronic and complex conditions is recognised and that nursing care encompasses self-management and the emphasis on wellness through purposeful interventions.

Health is recognised as holistic, dynamic in nature, and culturally driven. Nursing focuses on the provision of care that meets a person's multidimensional holistic health care needs over the life span.

This comprehensive course has a strong practical and applicable focus preparing graduates for current and [safe work practices as an Enrolled Nurse](#). The program utilises a variety of teaching methods to address the learning needs of the student. These include problem based learning through tutorials, lectures, on line learning, practical skill simulation labs and clinical placement in a variety of healthcare environments.

The knowledge and skills gained from this program will provide the student with a pathway to various [exciting career opportunities](#) within the healthcare industry.

What will I Learn?

The Diploma of Nursing is made of 25 units that cover the broad spectrum of learning required for a medication and intravenous endorsed enrolled nurse. You will gain the skills and knowledge required to work as a safe and competent enrolled nurse in any health care setting ranging from aged care to acute hospital settings. You will learn how to link your theory to practice, going from a classroom setting to the simulation lab and clinical placement. On completion of the Diploma of Nursing, you will be eligible to register with the Australian Health Practitioners Regulation Agency (AHPRA) which will enable you to work as an Enrolled nurse in Australia.

Course Outcomes and Career Opportunities

On completion of the Diploma of Nursing, you will be eligible to apply for register with the Australian Health Practitioners Regulation Agency (AHPRA) to [work as an Enrolled nurse](#) within Australia. You will need to meet the Nursing and Midwifery Board of Australia (NMBA) requirements for registration, including the registration standard on English language skills. You will be able to work across a wide range of healthcare settings including aged care, acute hospital settings, [community settings](#), medical clinics and [pathology clinics](#), with many more opportunities becoming available to enrolled nurses.

Please note: it is a requirement upon enrolment into the Diploma of Nursing course that you are registered with AHPRA as Diploma of Nursing students. For further information on the registration requirements view [the Factsheet and FAQ for student registration](#).

Pathways

This course offers a pathway into a Bachelor of Nursing at Deakin University, Warrnambool Campus.

Placement

Clinical placement opportunities are integrated into the course to support the development and consolidation of skills and knowledge within the nursing environment enabling the safe application of theory into practice. 440 hours of clinical placement across various clinical areas ([Aged Care](#), Community, Mental Health and Wellbeing, Subacute and Acute) are a mandatory and essential aspect of the course. This is not only an opportunity to experience different perspectives in the nursing profession but also allows you to recognise where you believe you would like to work in the future, and an opportunity for the healthcare facilities to recruit excellent nurses.

You will have a clinical placement briefing before each placement to examine the objectives that are applicable to each specific placement. You will be assisted to set personal and professional learning objectives and are expected to maintain a reflective journal to assist the development of reflective and critical thinking skills. Throughout the clinical placement, you are "buddied" with Registered Nurses who facilitate with clinical support and supervision. The SWTAFE Clinical Placement Coordinator will also be available to discuss any concerns and will conduct placement visits throughout the year.

A clear Police Check and Working with Children Check is required to attend clinical placement. Health facilities also require proof of a current Immunisation record for COVID19 and influenza. Please discuss this with the Program Coordinator if you have any concerns.

Placement occurs across a wide range of locations and there is an expectation that you will travel for placement if required. Placement is unpaid work experience and you are responsible for all associated costs such as accommodation, meals etc. whilst on placement.

Information Session

An information session is the first step to applying to start studying nursing

If you are interested in applying to study the Diploma of Nursing to start in February in Warrnambool or Hamilton, you'll need to attend an upcoming information session. These information sessions cover everything you need to know about nursing studies and are a mandatory first step to applying for this course.

Course Requirements

This section gives you an overview of entry requirements, course units and electives, skills recognition, and assessment criteria.

Entrance requirements & pre-requisites

Entry Requirements for this course include;

- Applicants must be 18 yrs old by time of 1st placement
- Applicants apply directly to South West TAFE.
- Applicants must complete a Pre-training review (PTR)
- Applicants are also expected to have suitable language, literacy, numeracy, communication and technology skills to undertake the Diploma in Nursing.
- Applicants will be required to attend an information session, after which they will be required to complete a literacy and numeracy (LLN) entrance test and a written assessment. The LLN entrance test is supervised and not supported. Applicants must satisfactorily complete this LLN test with an ACSF exit level 3 to meet the course selection criteria. Applicants who complete the examination successfully will be requested to participate in an interview process at a proposed date and time.
- The Diploma of Nursing is delivered and assessed in the English language. All applicants must be able to demonstrate that they meet one of the below pathways.
 - Pathway 1 - English is their primary language
Applicants must sign a declaration that English is their primary language. This means that English must be the language the student primarily uses for reading, writing, listening and speaking and the language they know best and are most comfortable with.
 - Pathway 2 - Test pathways
Applicants can provide evidence of having sat and successfully achieved the required score in one of the approved testing listed below:
 - IELTS (academic module) minimum overall score of 7 and a minimum score of 7 in each of the four components
 - OET with a minimum score of B in each of the four components
 - PTE (academic) with a minimum overall score of 65 and a minimum score of 65 in each of the four communicative skills
 - TOEFL iBT with a minimum total score of 94 and a minimum score of 24 in listening, 24 in reading, 27 in writing and 23 in speaking
- This English language requirement must be demonstrated prior to entry into the Diploma of Nursing and you will be required to complete relevant documentation during the application process. This documentation will be a signed declaration stating that English is your primary language or a completed English language test as per the NMBA English language standard.
- Please note that it is now a requirement that all healthcare workers, including nursing students on placement, are vaccinated against COVID-19 and Influenza. Applicants will need to provide evidence of their COVID-19 and Influenza vaccination status as part of their application.

Course requirements

Applicants must be able to provide the following as part of their enrolment into the Diploma of Nursing.

- A National Police Check (any disclosures are to be discussed with the Teaching Education Manager on an individual basis). This must be provided prior to enrolment.
- A volunteer Victorian Working with Children Check. This must be provided prior to enrolment.
- A record of current immunisation status and immunisation history (forms will be provided for students to have their doctor complete). Serology may be required. Please note that it is a requirement that all healthcare workers, including nursing students on placement, are vaccinated against COVID-19 and Influenza. Applicants will need to provide evidence of their COVID-19 and Influenza vaccination status.
- A statutory declaration to declare that applicants do not have an international police record (forms will be provided to students).
- Completion of 440 hours of clinical placement across a variety of settings. These placements may occur across the State, so travel will be required for some placements.
- Clinical placement uniform will be required to be purchased. This includes placement shirts, appropriate navy pants and appropriate enclosed footwear. A placement shirt will be organised by the facility.
- You will need to have access to an electronic device i.e. laptop or tablet to utilise during class.
- You will need to purchase text books on enrolment into the course (a booklist will be provided)

Please note: South West TAFE will only grant credit for HLTENN units from ANMAC approved Diploma of Nursing courses.

Assessment

This course involves accredited units. You will be required to complete assessment tasks to demonstrate your underpinning knowledge, skills and attributes to meet the course outcomes. A combination of written, oral and practical assessment strategies will be used in either a classroom, online or workplace environment.

Where units require demonstration of skills in a workplace environment, you will have the opportunity to do this either in your own workplace (where appropriate), through a practical placement, or by using one of the Institute's simulated workshops/classrooms. Detailed information about the types, conduct and dates of assessments will be provided in advance. You will also be provided with information about the opportunity for reassessment and appeal.

After applying

Once you have applied for your chosen course, you will receive a thank you email from South West TAFE with a few steps to help process your enrolment.

You will receive an email to complete a Pre-Training Review online evaluation. This evaluation helps us tailor your training to suit your needs.

Skills recognition

Fees

This section gives you an overview of course fees, subsidies, and how they can be paid.

Course Fees

Here's an outline of fees and costs associated with your course.

Your fees each year can be made up of 3 different elements. Everyone has different circumstances that can affect what you pay and how much you pay. :

1. Tuition fees - charged as an hourly rate that varies from course to course. A large portion of the tuition is subsidised by the Victorian Government for eligible students.
2. Resource and/or materials costs - covers the cost of materials and other incidentals. This fee will vary according to the course being undertaken.
3. Booklist items - such as textbooks, equipment and stationery recommended for your course

Tuition fees

There are 4 different rates of tuition fees. Only one will apply to you (depending on your eligibility and circumstances).

1. **Government Subsidised Fee** - you could be eligible for a government-subsidised rate under the Skills First funding depending on your age, educational history, and citizenship or residency status. If you are eligible, the government will contribute to the cost of your training.

2. **Government Subsidised Concession Fee** - If you are eligible for a Skills First government-subsidised place and hold a current healthcare or pension card, that you can provide at enrolment, you may be eligible for the concession rate. Note, the concession rate is not applicable to Diploma level courses.

3. **If the course is a Free TAFE course or part of the Free TAFE Pathways Program** - Eligible students will not pay course tuition fees for the duration of their enrolment in this course, however, there may be some consumable/material fees for the course (find out more below). 4. **Full fee** - If you are not eligible for a Skills First government-subsidised place, exemption, concession or are enrolling in a course that isn't government-subsidised, you may be required to pay the full fee rate.
